**2010- 2011 STORAGE AGREEMENT**

Now therefore, in consideration of the agreements herein, the parties agree that:

1. In consideration of \$\_\_\_\_\_ payable by Owner, **with 50% due now and balance due by December 1, 2010.** Boat will be stored **from October 15, 2010 through May 15, 2011.** Any balance unpaid by due date is subject to a 2% late fee minimum of \$5.00 per month. Any boat not picked up by due date is subject to a rate of \$10.00 per day.
2. WWW Boat Services, Inc. shall not be responsible or have any liability for any loss or damaged to the boat or personal belongings of Owner and/or other occasioned by theft, fire, or other natural disaster beyond the reasonable control of WWW Boat Services, Inc.; and Owner shall cover any risks by insurance without any right of subrogation against WWW Boat Services, Inc. Any damage caused by freeze will not be at the liability of WWW Boat Services, Inc.
3. Owner shall remove all personal effects from PWC/boat.
4. No person, other than an employee of WWW Boat Services, Inc., or owner of boat shall work on the boat during the storage period without prior approval of President or designated employee of WWW Boat Services, Inc.
5. In the event of an emergency, WWW Boat Services, Inc. shall have the right to move PWC/boat to any other available location.
6. Owner shall furnish to WWW Boat Services, Inc. a set of keys to the PWC/boat for emergency purposes.
7. Location of boat in storage area will be at the discretion of WWW Boat Services, Inc. personnel.
8. In/out options must be negotiated at beginning of lease.
9. Finance charges will incur on all late payments.
